PARTICIPANT WAIVER/RELEASE OF LIABILITY—READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the MMAC program, I the undersigned, acknowledge, obligate myself, and agree that the risk of injury from the activities involved in this program is significant, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist, including, but limited to, the potential for permanent paralysis, death, broken bones, dental injuries, etc; and I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF MMAC, or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation. If however I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such hazard to the attention of the nearest official or employee immediately; and I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS MMAC and, if applicable, owners and lessors of premises used to conduct the program, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss of damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF MMAC OR OTHERWISE, to the fullest extent permitted by law. Student agrees that the civil code regarding general release in the state of domiciliary shall have no effect. Student furthermore agrees that this general release shall extend to claims which the creditor/student does not know or suspect to exist in his/her favor at the time of executing the release, which if known by student must have materially affected and settlement with MMAC. Student hereby waives all rights under the civil code section.

This is to certify that we, as parents/guardians with legal responsibility for this participant, do consent and agree to his/her waiver/release as provided above for all the Releases, and, for myself, my heirs, assigns, and next of kin, I and my spouse release and agree to indemnify and hold harmless the Releases from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law. I HAVE READ THE RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
